Election Day is Tuesday, November 5, 2024.

Oregon has a safe and reliable Vote by Mail system, laws that protect your right to vote, and highly trained, local election workers.

If you registered to vote before **October 15, 2024**, you will automatically receive your ballot in the mail. To check the status of your registration and ballot, visit the Oregon Secretary of State's My Vote webpage at www.oregonvotes.gov/myvote.

Ballots can be returned in any of the following three ways:

- By mail, using the postage-paid envelope provided, if received or postmarked by 8:00 pm on Election Day.

We recommend mailing at a local post office to ensure your ballot is postmarked on or before November 5th. Dropping a ballot in a mailbox on Election Day does not ensure a timely postmark as pickup times may vary.

- At official drop box locations by 8:00 pm on Election Day, **November 5**. For drop box locations and hours, visit Oregonvotes.gov/DropBox.
- In-person at any county elections office locations by 8 pm on Election Day. To find the elections office closest to you, visit Oregonvotes.gov/Counties.

Oregon also has laws that protect your right to vote. Those laws make it a crime to:

- Harass an election worker. ORS 166.065(4).
- Use or threaten force, violence, or restraint to make a person refrain from voting. ORS 260.665.
- Obstruct a place designated for ballot drop-off. ORS 260.695(3).
- Engage in unlawful paramilitary activity. ORS 166.660.
- Remove a ballot from a place designated for ballot drop-off. ORS 260.695(10).

Attorney General Ellen Rosenblum is activating the Attorney General's Voter Protection Hotline on October 14, 2024.

Oregon law also allows members of the public to observe some ballot handling processes, including signature verification and counting. For more information, contact your county elections office.
